
As of December 31, 2025, DENR Region X attained an overall accomplishment of 140.35% of its CY 2025 Coastal and Marine Ecosystems Management Program (CMEMP) targets. The exceedance beyond the 100% target was due to demand-driven activities, particularly the provision of technical assistance to coastal and marine-related concerns. With this, although PENRO Camiguin had no target for this indicator, it was able to assist eight (8) requesting partners and stakeholders, resulting in a 493% average regional accomplishment.

Under the Social Marketing component, the regional target was four (4) special events; however, pursuant to the Memorandum dated January 14, 2025 issued by then Assistant Secretary for Biodiversity and concurrent BMB Director Marcial C. Amaro, Jr., CESO II, eight special events aligned with CMEMP objectives were designated for celebration. Consequently, this Office conducted seven special events, translating to a 140% regional accomplishment.

Moreover, under the NIPAS-MPA Capacity Building component, the Regional Office hosted the national training, enabling selected CRFMS staff to serve as support personnel. Despite this role, they were officially recognized as training participants, as their active participation was at times requested to augment the number of participants and contribute to the successful conduct of the 10-day national training.

Overall, the CY 2025 CMEMP targets were efficiently accomplished, in accordance with the approved Implementation Plan and Work and Financial Plan.

					The BPLS-PAMO staff carried out direct environmental actions to address existing threats within the Baliangao Protected Landscape and Seascapes - Protected Area (BPLS-PA). Various waste materials, such as plastic bottles, metal cans, plastic twine, sachets, and other nonbiodegradable debris, were observed in the mangrove areas along the boardwalk. These findings highlight the need for immediate pollution control measures and continuous efforts to preserve the ecological integrity of the site. On October 15, 2025, a coastal clean-up activity was conducted along the mangrove areas of Barangay Misom to address the accumulation of solid waste that was affecting native vegetation and coastal biodiversity.
